RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

ACKNOWLEDGEMENT AND ASSUMPTION OF RISK

COVENANT NOT TO SUE

REPRESENTATION OF ABILITY TO PARTICIPATE
